The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00** hours on **2076/12/11(24<sup>th</sup> Mar 2020)** at the office of Surunga Municipality,Madhupatti, Saptari. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. as mentioned above in the table which shall be valid for 30 days beyond the validity period of the bid (i.e. at least till 2077/02/29(22<sup>nd</sup> May 2020)
